Candidates must clearly understand that the fee payable to the Upward Bound Trust does NOT include personal insurance cover and the Local Authority in making any grants towards the student's fees does not in any way assume responsibility for the safety of the student whilst taking part in the course. Students who belong to a youth organisation should ascertain whether any existing insurance includes cover for gliding. If not it is the responsibility of the students themselves to take our special insurance cover if they require such cover.

MEDICAL DECLARATION:

In order to solo a glider the pilot must have a signed declaration from his G.P. TO SHOW THAT HE/SHE IS AT THE MEDICAL STANDARD REQUIRED TO DRIVE A ROAD VEHICLE STANDARD DVLA Group 1. The declaration form can be obtained from the Upward Bound Trust Web site and should be completed and a copy made available to the club on the 1st day of instruction. The self declaration below must be signed to enable flying under instruction to take place should the Medical Declaration not be completed by the 1st day of instruction. The completed Medical Declaration must be made available to the Upward Bound Trust before flying a glider solo.
